1. Application submitted by the firm(s) in prescribed "Application Form" for each group only will be accepted.
2. All pages of "Application Form" shall be signed by the authorized representative of the firm.
3. The NSTI(W), Tura reserves the right to reject any application.
4. Preference will be given to those firms who are on the approved list of Govt. Dept. & Public Sector Undertaking or ISO Certificate holders or dealers authorized by manufacturers.
5. Intimation with regard to registration of the firm as "Approved Supplier" or otherwise will be communicated to each firm.
6. The registration as "Approved Supplier" will be kept valid for a period of 01 (one) financial year. However, it will be reviewed, once in a year, eliminating firms which may have gone out of business or whose performance has been found to be unsatisfactory.
7. Prescribed "Application Form" may be obtained either from NSTI(W), Tura site www.rvtitura.gov.in or from the Institute office.
8. If NSTI(W), Tura registers any firm as approved Supplier, he/ she has to supply the material at NSTI(W), Tura store and he/ she has to accept the NSTI(W), Tura payment terms i.e. Payment shall be remitted only to Firm's account number from the date of supply of the material in good condition through PFMS.
